## CONTRACT AGREEMENT

THIS AGREEMENT made the 22<sup>nd</sup> day of September 2021 between Director (Logistic and Supply) & Line Director (Procurement, Storage & Supply Management), Directorate General of Family Planning, 6, Kawran Bazar, Dhaka-1215 (Hereinafter called “the Procuring Entity”) of the one part and JMI SYRINGES AND MEDICAL DEVICES LIMITED, Unique Heights, Level-11, 117, Kazi Nazrul Islam Avenue, Ramna, Dhaka-1217 (Hereinafter called “the Supplier”) of the other part:

  - g) Price Schedules and Schedule of Requirements and;
  - h) other document including correspondences listed in the PCC forming part of the Contract

In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and related services and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
